### **INTRODUCTION**

Charles Sperry Greear is a twenty-seven-year police officer and a fifteen-year veteran of the Idaho State Police. He recently retired from the Detective division in Coeur d'Alene as a Senior Detective. There, he worked in Criminal Investigations; specializing in drug investigations and crimes against persons.

Charles Greear is an ACTAR-Accredited Collision Reconstructionist, a certified Crash Data Retrieval Specialist and a certified Event Data Recorder Analyst. During his tenure with the Idaho State Police he was certified as a Breath Testing Specialist, a Drug Recognition Expert, a Field Training Officer and a Standardized Field Sobriety Test instructor. He is also certified by Idaho P.O.S.T. as an instructor for Crash Investigation, Collision Reconstruction, DUI Investigation, Traffic Code and Collision Scene Management. He is still actively instructing in these disciplines for the Idaho P.O.S.T. Academy.
